An independent panel of judges will be appointed by the NZPSA President whose decision will be final. The prize is intended to be received by only one student but it can be shared by one or more students on the recommendation of the NZPSA President.

## **Undergraduate Essay Prize for New Zealand Politics**

#### Details

Due to the generosity of Raymond Miller each year a prize of \$500 will be awarded for the best undergraduate essay submitted as part of the requirements for a course on New Zealand domestic politics. One nomination per year can be made by a Head of Department at any New Zealand University. It will be expected that the Departments nominating an essay will have taken full precautions against any possible plagiarism and will be held fully responsible if this proves not to be the case. The NZPSA President will appoint a panel of judges including a representative from the University of Auckland as the administrator of the prize. When Raymond Miller is available, he will be included as a member of the judging panel. The panel's decision will be final. The prize is intended to be received by only one student but it can be shared by one or more students on the recommendation of the NZPSA President.

## 2012 UK PSA Conference Award – Submissions due September 15<sup>th</sup> 2011

## <u>Award</u>

- UKPSA: The UK PSA which is held around April of each year offers up to 2 NZPSA members free registration, up to 3 nights and accommodation, and usual meals at the conference. They may also assist with airfares. Once delegates are accepted for this award, the UK PSA will automatically accept the chosen delegate's paper in the conference. The UKPSA may also assist with airfares depending

on budget and demonstrated need. In return, the NZPSA offers 1-2 United Kingdom PSA members are also eligible for free registration at the annual NZPSA Conference, usual conference meals, and up to three nights conference accommodation.

Generally, the NZPSA decides which of their members receive these benefits; just as the overseas organisation selects which of their members receives benefits at our conference, although in 2010 the UKPSA made the decision. Priority for these benefits will be given to new and emerging New Zealand scholars. Recipients are asked to write a short report for the NZPSA newsletter on the conference to share their experience and raise awareness of the awards and cross-association relationships.

#### Applying for This Awards

Those interested in applying need to make an email submission to the NZPSA President (j.lees-marshment@auckland.ac.nz: or acting president) by the set deadline. Please send: Your CV; Affiliation; Paper-title; Abstract; Evidence of acceptance of your paper (or explanation of submission/acceptance deadlines); A short paragraph outlining the reasons why you should receive it. eg If you are an emerging scholar, whether you have any other funding, importance of the conference to your research, and the potential benefits to the NZ research community. We will allocate on a needs basis in the first instance.

The NZPSA will decide and notify the applicants and the UKPSA by mid-October at the latest. Those who receive the award need to then liase with the UKPSA regarding local arrangements and potential travel assistance.

# Ethics and the Acquisition of Organs: Issues in Biomedical Ethics

Transplantation is a medically successful and cost-effective way to treat people whose organs have failed--but not enough organs are available to meet demand. Ethics and the Acquisition of Organs is concerned with the major ethical problems raised by policies for acquiring organs. The main topics are the rights of the dead, the role of the family, opt in and opt out systems, the conscription of organs, living organ donation from adults and children, directed donation and priority for donors, and the sale of organs.

In this ground-breaking work, T. M. Wilkinson uses concepts from moral and political theory such as autonomy, rights, posthumous interests, justice, and well-being, in a context informed by the clinical, legal, and policy aspects of transplantation. The result is a

rigorous philosophical exploration of real problems and options. He argues that the ethics of acquiring organs for transplantation is not only of great intellectual interest, but also of practical importance. As such, this book will be of profit not only to students and academics who work in applied ethics and bioethics, but also to the lawyers, policymakers, clinicians, and lobby groups interested in transplantation.

Readership: Scholars and advanced students of medical ethics, moral philosophy, and medical law; healthcare professionals interested in ethics.

It is produced Monday to Friday and is distributed via email to academics, students, political journalists, bloggers, MPs, policy analysts and political activists. The document is available for research purposes only, and it's free. To

The full reproduction of material in NZ Politics Daily is mostly derived from the mainstream media and the blogosphere, and it includes links to broadcast material such as that on TVNZ, TV3 and Radio NZ, as well as political cartoons. The selection criterion for inclusion in NZ Politics Daily is simply anything that is "informative, insightful, interesting or influential". No endorsement of the material is made, and obviously it'd never satisfy everyone, but an attempt is made to include

material from a diverse range of ideological perspectives.

The document is normally about 40-70 pages long, and it begins with a summary of the highlights, and then has a table of contents page with hyperlinks (which means you can click on them and jump to the particular item in the document). I've been doing this since the start of the year.

## **UK PSA Attendees' Experience**

As a final-year PhD student in political studies at the University of Otago I was fortunate enough to be selected by the UK PSA to attend their 61st Political Studies Association Annual Conference. Against the backdrop of a surprisingly sunny and balmy London, the theme of the conference was 'Transforming Politics: New Synergies', which lent itself to a wide and fascinating range of panels, papers, lectures and informal discussions on new ideas in political studies today.

The event proved to be an excellent opportunity to meet and network with other academics. Personal highlights included panels addressing the role of religion in contemporary politics and the emergence of atheism as a pseudo-political movement, the current state of democracy and the prospects for the emergence of a global democratic polity. Additionally, I also found Professor Tony Wright's lecture on the then-upcoming UK national referendum on the 'Alternative Vote' system, and Sir Michael Aaronson's talk titled 'Libya: Did we have a choice?' highly

stimulating as they provided an unvarnished British view of current events.

For my part I presented on the efforts of the United States and its allies to deploy a globespanning ballistic missile defence shield, which has resulted in criticism by great powers such as Russia and China. I argued that it is possible to transform the currently divisive and destabilising role missile defence has played by offering to co-operate on the deployment of joint missile defence systems with Russia and China, and examined possible practical steps to achieve this. I received excellent feedback on my paper, and generally found that other academics were receptive to my analysis, although many lamented the realist and 'state-centric' framework which largely appears to guide state actions within the international system, a sentiment I agreed with.

Overall, the conference proved to be highly rewarding on both a personal and professional level as the discussions I had with a number of people have since facilitated my on-going research. Needless to say I am incredibly grateful to the UK PSA for arranging to have me attend the conference.

I was very fortunate to attend the UK PSA conference in April 2011. It was attended by around 500 academics from Britain and around the world. The session topics were as interesting as they very varied. In large

conferences like this one, many sessions are being conducted at the same time, so it is unavoidable that some cannot be attended. The attraction of the British conferences for me is that they do compliment research in former colonies such as New Zealand, both in terms of subject matter and research methodologies. My own session, on Political Parties, was remarkable for the synergies

between papers. My paper, on the Historical Antecedents of Conscience Voting, was complemented by one on an empirical study of New Political Culture and another on current directions in ideology in party decision making. Good questions were asked by the audience, and I was both inspired and encouraged that my own work was being actively following in the antipodes.

As is not uncommon, the conference was also notable for the quality of the lunches. Gone are the days of my youth when lunch was a couple of sandwiches and an apple in a brown paper bag. But the lunches (and the dinner) are opportunities to meet interesting people who are doing fascinating research, and this conference did not disappoint.

#### Former Student's Experience in New Job

Following the completion of my Master of Arts in Political Studies from the University of Auckland in 2009 I faced the same problem a lot of recent graduates face in these somewhat grim economic climes - what do I do now? While I could continue to tutor at the Department (which I did), a more long term solution was required. It was about this time that a friend pointed me in the direction of the Ministry of Foreign Affairs and Trade. Not too sure on the specifics of what they did, I was nonetheless drawn to the promise of diverse, challenging and analytical work. It turns out that I underestimated the extent to which I would wind up doing all three of these.

The Ministry of Foreign Affairs and Trade (or MFAT as it is known in the industry) is tasked with representing, protecting and promoting New Zealand's, and New Zealanders', interests abroad. No mean feat, I assure you.

MFAT's role takes the average Policy Officer (such as myself) from international negotiations to trade exhibitions to defence deployments to representing New Zealanders' rights abroad. Everything from bidding for a giant telescope to be built in New Zealand to tackling climate change to negotiating free trade agreements falls within our ambit.

Beyond variation, the work is also challenging and analytical. In this respect, my MA has stood me in good stead, equipping me with the skills and diligence needed to deal with an ever-changing and demanding work load, and fast-paced environment. So if the idea of working overseas representing New Zealand, shaping New Zealand foreign policy, doing some juicy policy work and dealing with screeds of variety sounds appealing, perhaps a career at MFAT is the thing for you. If that is the case, you might want to consider how exactly you are going to get here, starting with a good degree from a respected university.
