2019 NZPSA Annual Conference

The Department of Political Science and International Relations at the University of Canterbury is very pleased to be hosting the 2019 NZPSA Conference in Christchurch. The conference will be held on the **27th-29th of November** with a postgraduate workshop on the morning of the 27th of November.

Conference Theme: Community, Security, Humanity.

On the afternoon of 15 March, 2019, a gunman attacked two Mosques in Christchurch, killing fifty innocent civilians and wounding fifty more. The reverberations from this horrific act of terrorism have overturned many of the previous assumptions about New Zealand politics and society, generating vital debates about the nature of our community, the ways in which we think about security, and the interaction between these events and our broader sense of humanity.

NZPSA 2019 presents us with an opportunity to consider how this violent rupture impacts upon and transforms our way of thinking about politics in this country and in the wider world. These themes emphasise both differences and commonalties; the recognition that each community is always composed of a multitude of different communities, all sharing the common expectation that they can live their lives with a reasonable degree of security and dignity.

There are no set streams for this conference as we aim to encourage intersectional conversations on common themes, so panels will be constructed primarily on a thematic rather than disciplinary basis.

Multi-stakeholder Engagement for the Sustainable Development Goals: Ethical and organisational challenges Agenda 2030 and its 17 Sustainable Development goals (SDGs) have been widely adopted by businesses, governments and Civil Society Organizations (CSOs) since their introduction at the United Nations Sustainable Development Summit. Our focus is that action for Agenda 2030 is partly impeded by its overall complexity and all issues related to it. Organizations are limited in the support they can offer to innovate towards accomplishing the SDGs. The intricacy of the 17 agendas and the diversity of stakeholders related to issues addressed by organizations can be seen as a force as well as a threat. The diversity of stakeholders affected forces organizations to pursue multi-stakeholder engagement and collaboration in order to achieve the SDGs. The United Nations acknowledges that progress on the SDGs agenda is too slow, asking how we can accelerate the pace for change. Call for Papers: "The Future of Public Audit" Financial Accountability & Management Special Issue And Workshop

The audit profession has been under an ongoing 'rumbling' controversy of not being fit for purpose that has made it the subject of great scrutiny and much debate that will continue into the 2020's, with critical questions asking whether audit is able to meet the expectations of society. The special issue is interested in any paper that addresses the current state of public audit, where it may be heading and what are the implications for society and the public interest. The SI is open to all forms of methodology. This includes historical, archival, field study and comparative studies among others. We would particularly be interested in any studies that involve co-authoring between academics and practitioners, although the research would be expected to make a substantive theoretical contribution. A workshop will be held in London, England, on June 18th, 2020. Authors wishing to present at the workshop should submit a paper proposal (maximum 2 paged in length) to Laurence Ferry (<u>laurence.ferry@durham.ac.uk</u>) by February 28th, 2020. Authors of selected papers from the workshop will be invited to submit revised papers for this special issue, subject to the journal's normal review processes. Attendance and/or presentation at the workshop is <u>not</u> a pre-requisite for submission to the special issue. Accounting and accountability for the digital transformation of public services

Digital technologies are increasingly transforming public services. Governments are (more or less voluntarily) widely adopting social media, analytics, machine-learning-based algorithms and artificial intelligence tools. Such technologies are claimed to ensure better engagement with stakeholders, through the delivery of smart(er) public services and personalized public policies. This special issue aims to enhance the theoretical and practical understanding of accounting and accountability in the digital transformation of public services and policy practices, with particular reference to opportunities, risks and challenges that digital data and digital technologies are bringing to accounting and accountability in public service organizations. We encourage theoretical, conceptual and empirical submissions from different institutional contexts and by scholars across disciplines.

11-12 November 2019, Brisbane, Australia

The Knowledge Futures Forum will bring together up to forty early career researchers (ECRs) from the UK, Australia, New Zealand and the Pacific region, from across the humanities and social sciences to discuss key questions around a "futures" theme. 24th Annual IRSPM 2020 Conference

22-24 April 2020, Tampere, Finland

The theme of the IRSPM 2020 conference is "Smart Public Services?" Smart public services make life easier for their service users, involving as they do the application of technologies and effectively designed service systems to solve problems that users cannot solve alone. Opportunities vary between locales and sets of users, and over time the processes and goals of public services, too, vary and are in constant need of discourse around relevance and appropriateness. Smart public service addresses a number of themes, such as smart cities, smart service design and service processes, evidence-based public services and the use of smart technology to deliver public services. We envisage research presentations on leading public service design being rooted in practice, while heralding debates beyond NPM, beyond governances, emergent hybrid organising, and beyond the management of networks focusing on advances in co-creation and public value. https://events.tuni.fi/irspm2020/
