Workshop on Studying Political Science/Studies in NZ

Juliet Lodge, University of Auckland, has suggested that this workshop would provide a useful opportunity to find out what the aspirations of political science/studies students are, and about their attitudes to the discipline in New Zealand She has suggested further, that a survey of politics majors (third year and honours students) could be made at enrolment in 1976 without too much difficulty, at each of the universities. She points out that if there is general agreement that this is useful, then arrangements would have to be made, and the questionnaire drawn up and duplicated before the end of the vacation period. Stephen Levine has expressed interest at being involved at Victoria University, and helping to design a suitable questionnaire. Anyone else interested should contact him without further delay; ideally, one person is needed at each university to act as local coordinator of the project.

NZ Political Science in Search of Self - A Comment

Given the imminence of the first NZPSA conference, and the profusion of student enquiries as to the distinctions between "politics", "political studies" and "political science", it seems opportune to consider the state of the discipline in New Zealand.

To some extent the decision taken in 1974 by New Zealand political scientists to create a Political Studies Association established "politics" as a discipline in its own right, separate and distinct from history, sociology and economics. But the debate surrounding the adoption of the Association's nomenclature indicated continuing incertitude vis-a-vis both the legitimacy and validity of applying "scientific" approaches and tools to the study of political phenomena; and dissonance over the discipline's identity. Aside from the issues posed by compartmentalization of "political science" at a time of inter-disciplinarianism, it is to be hoped that clarification of the identity and orientation of the discipline in New Zealand is possible and

that it might help us to avoid sharing with our British counterparts in the UKPSA the dubious honour of being "the least professional and most backward of the social sciences" (Ivor Crewe).

So what is the state of the discipline in New Zealand? Are we prepared to admit that politics is a social science and that quantification has a place? Are we to forever shun behaviouralism and post-behaviouralism, or are we already unwittingly flirting with bio-behaviouralism? Has increasing awareness of the consequences of socalled modern "bio-technologies" renewed our interest in forms of political society not merely consistent with survival and human ideals, but "good" in the classical sense of being in harmony with Human nature and "good" in the sense of promoting a better and just society for all? Or was this interest born of desires to reunite "politics" with philosophy? Do we know, do we need and wish to know where we are going? And, if so, are there directions in which we should move (possibly assisted by a Social Science Research Council, and international data archives)? Should the NZPSA conferences define any such directions and help in the attainment of objectives? This in turn raises the question of the purposes, functions, and aims of conferences.

According to Ivor Crewe, the UKPSA's 1975 conference marked the turning point in the association's 25 years of what he terms "benevolent paternalism" when a "new guard" was swept in promising to treat the conferences seriously - a step he welcomed on the grounds that enjoyment of convivial booze-ups not-withstanding the "customary thinness of numbers and activities, the pervading atmosphere of gentle muddle, the cultivated casualness of approach all reflected an underlying lack of confidence in political science as an academic discipline. So if, for the sake of the argument, conferences do indeed reflect a discipline's self-image, what is ours? Can we and should we seek to determine it, and in so doing manage to avoid Crewe's "amateur, gentlemanly British tradition" and the "Madison Avenue model"?

Size alone should enable us to avoid "Madison", but size itself introduces special problems as was noted in 1974. Even if a solution is found by reactivating the idea of multidisciplinary conferences and inviting participants from cognate disciplines, it still remains for us to decide how best to organize conference activities to maximize payoffs.

The week-long conferences of the European Consortium for Political Research which oblige all participants to present a paper and attend workshops having clearly defined foci might not go down too well here. But the ECPR's system certainly advances a major purpose of conferences: research. It provides an opportunity for the statement of interim results, progress reports, and experimentation with tentative ideas facilitating interchanges with fellow specialists.

Perhaps the time has come for us to critically appraise the academic as opposed to social functions and aims of our conferences. This may well demand that we not only delineate and evaluate objectives, and agree to actively promote the discipline (encouraging at a minimum inter-university cooperation and collaboration), but that we open our minds to "foreign" developments in the discipline which may well provide us with useful insights and stimulate our own research. If we omit to do so we may well be asking ourselves the same questions in 1986.

PROPOSED RULES AND CONSTITUTION OF NZPSA

UNDER THE INCORPORATED SOCIETIES ACT 1908

Note

The following draft rules and constitution for the Association have been patterned after other similar professional associations and adapted to New Zealand's particular circumstances. They have been circulated in advance to Area Coordinators and are now being published here in the Newsletter to elicit reactions from all members.

PLEASE SEND ALL COMMENTS EITHER TO YOUR AREA COORDINATOR OR TO THE NATIONAL OFFICE. Shortly after receiving comments on the draft, the National Office will be asking members to vote on acceptance or rejection of this or a revised version by means of a mail ballot.

Name

1. The name of the Society is the <u>NEW ZEALAND POLITICAL STUDIES ASSOCIATION</u> (INCORPORATED).

Objects

- 2. The objects for which the Association is established are:
 - (a) To foster the study of and research into social and political questions, especially those of particular interest to New Zealand.
 - (b) To provide a forum in New Zealand for the discussion of social and political questions among interested persons, irrespective of occupation, party affiliation, or political opinion.
 - (c) To disseminate information on social and political questions.
 - (d) In furtherance of the objects of the Association,
 - 1. To produce a newsletter;
 - To hold public meetings, lectures, conferences, summer and winter schools, study groups, and discussion groups;
 - 3. To collect, preserve, publish, and distribute books, newspapers, journals, periodicals, magazines, documents, manuscripts, and correspondence;
 - To assist with funds or otherwise any book, journal or other publication dealing with social or political questions;
 - 5. To develop a political and social internship programme;
 - To facilitate faculty exchanges;
 - To develop a research institute for the study of political, economic, and social questions of special interest to New Zealand;
 - 8. To cooperate, and where appropriate, to affiliate with any other association, institute or society having similar objects.

Membership

- 3. (a) Membership of the Association shall be open to all persons who accept the objects of the Association.
 - (b) No rights of membership shall belong to any member who is unfinancial. A member is unfinancial whose subscription is six months in arrears.
 - (c) Any member wishing to terminate his membership shall pay all arrears of subscription, if any, and shall forward his resignation in writing to the National Office.

Affiliation Fees

4. The annual membership fee shall be determined from time to time by the Executive of the Association. Only financial members shall have the right to vote for officers of the Association and to hold office. Payment of the membership fee shall entitle a member to receive the Newsletter and other publications designated by the Executive for general distribution to members.

Officers

- 5. (a) The Association shall elect an Executive consisting of:
 a President, a Secretary, a Treasurer, an Editor of Publications,
 and such Area Coordinators as may from time to time be established
 by the Executive of the Association. The Executive shall have the
 power to conduct the business of the Association between general
 meetings, and to fill any extraordinary vacancies that may occur.
 - (i) The President
 At all meetings of the Association and of the Executive, the President shall be Chairperson, and in his/her absence, the Secretary, or if both are absent, then a Chairperson shall be elected from those present. The President shall present the Annual or Biennial Report to the Association's general meeting.
 - The Secretary
 The Secretary shall attend and shall keep minutes of all general
 meetings and meetings of the Executive, and forward copies of
 the same to all members; shall call all general meetings and
 meetings of the Executive; and shall carry out such other duties
 as the general meeting or the Executive shall require.
 - The Treasurer shall attend all general meetings and meetings of the Executive and shall receive all moneys due to the Association and disburse under authority of the general meeting or the Executive all moneys payable by the Association; shall keep proper books of account, prepare such financial statements as are required, prepare an annual balance sheet, and shall produce all such account books as are required by the general meeting or the Executive; and shall carry out such other duties as the general meeting or the Executive shall require.
 - The Editor of Publications
 The Editor of Publications shall attend all general meetings and meetings of the Executive and shall be responsible for producing a newsletter; shall develop a plan for establishing an official journal of the Association; shall make recommendations to the Executive or to the general meeting regarding the collection, preservation, publication and distribution of books, newspapers, journals, periodicals, magazines, documents, manuscripts, and correspondence; and shall carry out such other duties as the general meeting or the Executive shall require.
 - The Area Coordinators
 The Area Coordinators shall be responsible for developing membership in their geographic areas, for calling such meetings in their areas as seem necessary, and for looking after local arrangements for general meetings to be held in their areas.
 - (b) Elections shall proceed by ballot prior to the general meeting. The Secretary shall circularise members informing them of the date nominations will close. The Secretary shall circulate the ballot paper with any relevant information supplied by the nominee to members at least twentyeight (28) days prior to the general meeting and the results will be announced at the general meeting.
 - (c) All officers will be elected for a two year term, renewable for one term.

- (d) In the case of positions which are not filled by the above procedure, nominations will be called for and the elections take place at the general meeting.
- (e) For both forms of elections specified above, the Secretary in consultation with one other member of the Executive shall appoint at least two scrutineers to supervise the counting of votes. Election shall be by simple majority.

Meetings

- 6. A general meeting of the Association shall be held at least every two years. The time and place of the general meeting shall be determined by the previous general meeting which may, however, remit the final decision to the Executive. Special general meetings may be called by the Executive at the request in writing of ten members of the Association. The quorum at general meetings shall be twenty members.
- 7. At least twenty-eight (28) days' notice must be given for the holding of a general meeting. The general meeting shall have power to consider proposed constitutional amendments and may vote on such amendments, but if such amendments are passed, they must subsequently be circulated to all members within twenty-eight (28) days, for final decision by postal ballot by majority of those voting. All other decisions taken at general meetings shall be by a simple majority of those present, and voting shall be by a show of hands unless a secret ballot is called for.

General Provisions as to Government

8. The Executive shall, subject to any express direction of the general meeting, have the entire management of the Association and the income and property thereof, and may do all acts, matters, and things to further the aims of the Association.

Common Seal

- 9. (a) The Executive shall provide and be responsible for the custody of a Common Seal of the Association.
 - (b) Whenever the Common Seal of the Association requires to be impressed upon any instrument the same shall be affixed pursuant to a resolution of the Association or of the Executive and in the presence of and shall be attested to by not less than three members of the Executive, one of whom shall be the President, the Secretary, or the Treasurer.

Sections

- 10. (a) With the approval of the Executive, any group of at least ten members of the Association, sharing a common interest in a particular field of politics (broadly defined), may constitute themselves into a specialised Section of the Association. Any Section shall have power to appoint a Committee.
 - (b) The Executive shall have the power to approve the constitution and the activities of a Section, to recognise it as such and to withdraw such recognition.
 - (c) A Section may, with the approval of the Executive, charge its members such fees as may be necessary to cover its expenses.
 - (d) A Section may organise its own conference, or make a separate contribution to the conference of the Association.
 - (e) Sections are not entitled to speak in the name of the Association.

Control and Investment of Funds

11. The Executive shall have power to manage the funds of the Association and to make rules concerning the management of such funds, provided that cheques and other documents must be signed by the Treasurer and at least one other member of the Executive. It shall have the power to borrow money. Income and property of the Association however defined shall be applied solely towards the promotion of the objects and purposes of the Association, and no portion thereof shall be paid or transferred directly or indirectly by dividend, bonus, or otherwise to any member of the Association.

Registered Office

12. The address of the Registered Office of the Association and notice of every change of situation of the registered office shall be sent to every member and to the Registrar in accordance with the Incorporated Societies Act, 1908.

Winding Up

13. In the event of the winding up of the Association, any assets remaining after the discharge of all liabilities shall be used for educational purposes as may be decided by the Public Trustee.

Conferences

Human Settlement - Urbanisation in Auckland

This conference was sponsored by the Commonwealth Human Ecology Council, the City of Auckland, the University of Auckland, and the Auckland Regional Authority as a preparatory exercise for the United Nations Human Settlement Conference - HABITAT is to be held in Vancouver in June 1976.

It had several interesting aspects for New Zealand political scientists. There was a series of papers on the process of urbanisation experiences in Auckland dealing with: growth, transport, planning, housing, urban renewal, social problems, minorities, urban economics, and the role of government. As well there were general papers presented by academics and officials from several Commonwealth countries on migration, urban/rural relations, settlement policy, development in the South Pacific, and environmental aspects of settlements.

It is hoped that the conference will provide the basis for a submission to HABITAT by the Commonwealth Human Ecology Council. The preparation of the submission is now actually in hand and will incorporate a digest of the Auckland papers as a case study in regionalisation.

It is also hoped to publish proceedings of the conference, possibly in book form. This could be extremely useful, since there is no manifold analysis of a New Zealand city, and, with the slow application of the Local Government Act 1974 to all urban areas, the experience of Auckland will become especially relevant in all community government studies.

In this context, one theme of the conference was the special relationships between Auckland and the other South Pacific communities. Again, so far as I am aware there is no comparable material available in this field. Whatever the influence of the conference in international and national policy-making the material generated at Auckland should be of considerable interest to teachers in all social science disciplines.

Japan Advisory Committee

The Japan Advisory Committee whose membership is drawn from business, government, and research circles, will be meeting in a conference sponsored by the New Zealand Institute of International Affairs in March 1976 in Wellington.

Marxist Studies

Concerned by the lack of communication between scholars working in the field of Marxist studies, an interim committee was set up earlier this year in Australia to promote communication with a bi-monthly bulletin. The Bulletin of Marxist Studies is aimed at those genuinely interested in Marxist studies, whether substantively, or through employing a Marxist methodology, throughout the spectrum of the social sciences. It was edited intitially by Marian Sawer (University of Adelaide), but the editorship will rotate among the committee from the first issue in 1976, when the bulletin will be published quarterly.

NZ Foundation for Peace Studies

Inaugurated in May this year with a series of lectures, seminars, films, and an address by Dr Norman A. Alcock of the Canadian Peace Research Institute, the New Zealand Foundation for Peace Studies is largely Auckland-based. It has been closely associated with the University of Auckland Centre for Continuing Education, and has begun a series of lectures this year under its auspices.

The Foundation has the general aim of creating a positive climate for peace in New Zealand, as well as the more specific one of establishing a University Chair to offer interdisciplinary courses in peace studies. With these objectives in mind, the Foundation has established links with churches, trade unions, service clubs, and the teaching profession, as well as with the public at large. It is non-partisan, but will act as a consultant to government institutions among others. Apart from this, specific activities that it has become involved in have included the organisation of texts for schools, the assembly of basic data relating to conflict situations, and the publication of papers.

Britain and the EEC: Exit, Voice, or Loyalty? (Juliet Lodge). To be published in Cooperation and Conflict, Vol. X, No.4, November 1975. Britain's relations with the EEC and its "renegotiation" are examined in terms of Hirschman's concepts of Exit, Voice and Loyalty. Through the analysis, limitations of Hirschman's approach become apparent and tentative modifications to the relationship existing between exit, voice and loyalty are mooted.

The thesis focuses on four areas, traced back to 1925: the control of broadcasting, the question of monopoly and competition, the development of news and controversial broadcasting, and the emergence of a "philosophy" of broadcasting in New Zealand.

M.C.A.

The Administration of Human Resources for Development (Talib bin Zulpilip). EDC December 1975. A number of factors are important in development, including capital, technology, land, and trade. One factor which looms more and more importantly in theoretical analysis and empirical research is the human factor. Mr Talib examines the effectiveness of human resources as an agent of societal development, with especial reference to education.

M.P.P. - Research Paper

The Case for Using Inflation Adjusted Accounting Statements for Price Control and Corporate Taxation Purposes (Paul Baines). EDC November 1976. The paper is based on the argument that the use, in periods of continued and rising inflation, of historic cost as the basis for financial statements is erroneous and leads to overstatement of corporate earnings, and in consequence to high taxation incidence, and to low price increases being granted by price control authorities. This means that capital is being eroded, resulting in declining financial viability of employing industries, falling investment capacity, and an inequitable return to certain factors of production, especially shareholders. The argument is to be investigated by reviewing current price and corporate taxation policies

and their recent historical development in New Zealand and other industrial countries, by discussing the implications of continued reliance on historic cost accounting conventions, and by examining alternative forms of inflation accounting and their economic implications. It will conclude with policy recommendations.

Research Projects

Town Clerks. John Halligan and Tom Smith are conducting an extensive questionnaire survey of Town Clerks in New South Wales. This research will later be extended to Town Clerks in other Australian states, and will include comparisons with the office in New Zealand.

Local Government in Australia. John Halligan and John Power are engaged in a comprehensive study of local government in Australia. They hope to publish the results of this in various Australian journals. They will notify further details of interest later.

Other Research

Labour Migration: The Case of Tonga and New Zealand (Rob Campbell). To be published in The International Labour Review, Nov/Dec 1975.

The Only Weapon: A History of the Wellington Drivers Union, 1899-1975 (Rob Campbell). To be published early in 1976.

New Zealand's Relations with the Pacific (Anthony Haas). The Asian Pacific Research Unit publishes monthly summaries of New Zealand relations - social, political and economic - with the Pacific, in Asia-Pacific Forum.

Pacific Communities in New Zealand. After working for some time on migrant education, and being involved with the formation of the various Pacific Island Regional Advisory Councils, Anthony Haas is planning to publish descriptive accounts of the political structure and aspirations of Pacific Islands communities in New Zealand.

The New Zealand Election, 1975

Two studies are presently in progress: a pilot study to build up a picture of the factors affecting voting behaviour in New Zealand, and a post-election opinion research project.

The pilot study is a joint project being carried out by Nigel Roberts (University of Canterbury) with Stephen Levine (Victoria University) and Anthony Wood (University of Otago), and financed jointly by the University Grants Committee and the University of Canterbury. It is using a market research firm to carry out 150 randomly selected interviews in each of six electorates, chosen for the wide range of characteristics they include. No typical electorates were chosen; the six used are Clutha, Dunedin North, Lyttleton, Rangiora, Wellington Central, and Karori. It is hoped that this study will be the basis for continuing research.

The second study is being organised by Alan Robinson and Stephen Levine (Victoria University), and is a postal survey of 4000 electors randomly selected from all 87 electorates. It is designed to explore the nature of

opinion at the time of the election, and the relationship of opinion on major issues to political behaviour and social background.

Labour in Power: Promise and Performance (edited by Ray Goldstein with Rod Alley). Published by Price Milburn for New Zealand University Press, November 1975. This is the first work which specifically attempts to assess a New Zealand Government's performance in office. It includes statements by each of the leaders of Labour, National and Social Credit parties as well as selected policy area assessments, a comparison of the second and third Labour Governments, and a critique of the existing composition of parliament.

Association members have contributed several of the articles. It is being sold for \$3.96, with proceeds going to the journal, Political Science, and the N.Z.P.S.A. It is suitable for courses which focus on N.Z. government and politics.
