minor and major sequences leading on to a Masters programme or a PhD in Women's Studies. Unfortunately we do not as yet have an honours programme. It is possible to arrange theses supervision in other departments for topics on women, feminism and gender.

We have two compulsory topics in the minor/major programmes:

- Representations on Women and Gender in Australian Society (WMN2110.08) The focus of this course is on Australian society and gender relations in the past (history), in contemporary society (sociology), and in the process of economic restructuring (geography). The key questions dealt with are: how women and men have been perceived in different societies and in different periods of history; the theories which have been formulated to explain patriarchy; and how women have been excluded from economic and spatial discourse. Topics covered include: the experiences of convict women transported to Australia; what nineteenth century women could expect from married life and paid work; what contemporary women can expect from life; how contemporary women are experiencing various processes of economic and social restructuring.
- 2. Marriage: Comparative
 Perspectives (WMN2120.08) This course
 will examine the significance for women of the
 institution of marriage in a number of different
 periods and cultures from ancient Greece and
 Rome to contemporary Indonesia. The
 documentation will include legal, polemical and
 literary texts, which will be considered within
 their historical context of ideology and practice
 and analysed to show the various theoretical and
 experimental ways in which they define the
 roles of women in marriage.

If you are interested I suggest you consult the Monash University Arts Handbook 1993 (ask at your local university library) for an outline of the subjects available as "optional subjects" across other departments. In Politics, for example, we offer The Feminist Challenge to Liberal Political Thought at 2nd and 3rd year levels and Gender in Asian Politics at 2nd and 3rd year levels. In 3rd year

Women's Studies we offer the following course taken by Assoc. Prof. Elizabeth Grosz: Sexual Difference (WMN3110.08) This course is designed to provide an introduction and an indepth analysis of one of the major sites of feminist theory in the 1990s, the debates surrounding the question of sexual difference. The course aims to introduce students to the terms and positions involved in the issues of sexual difference.

From this year, students have been able to take a major sequence in Women's Studies in their degree. Students are strongly recommended to take a double major, one in women's studies and the other in their chosen disciplinary, or interdisciplinary, area.

Gender and Politics at Sydney

Patricia Springborg

Reader in Government University of Sydney Sydney, Australia

At Sydney University I lecture Government II/III, Women's Studies II and Gender Politics (Government IV), both of which I have taught from 1989 to 1992 along with an undergraduate course on Politics, Ethics, Science and Technology, which had a small feminist component.

Government III: Women and Politics is a course conducted as one two hour seminar per week for each student. In the later seminars problems in feminist theory are debated by the students.

The course debates the following: Do women and men today occupy the same place in political life? What is the significance for our understanding of 'politics' or the fact that for so long politics has been seen as a man's world and that almost all great political theorists argued that women were unfitted for political activity and citizenship? The course introduces students to a new and rapidly growing body of research and to the lively debates on the question of women and politics. Issues

discussed include why it took women so much longer than men to win the franchise; women's political activities before citizenship; the manner in which women have been discussed in political science; the representation of women in parliament and the bureaucracy; women and political parties; the impact of recent legislation and policies to improve women's social position; the question of 'gender gap'; the political significance of the women's movement (past and present); women and the welfare state; women and the politics of personal life.

Politics Department, University of Adelaide

The Politics Department at the University of Adelaide places a major emphasis on the development of courses on women and politics and the mainstreaming of material on women. While a number of female colleagues have incorporated some material on women in their courses, particularly substantial contributions have been made by female lecturing staff who offer the following courses:

Dr Carol Bacchi

History of Feminist Thought is designed as a survey of contributions of feminist thinking, mainly, though not exclusively from the Anglo-Saxon tradition, from the mid-nineteenth century to today. There is an emphasis on the way in which various feminisms have challenged and reshaped preexisting 'malestream' theories. Women and **Policy** has several interrelated goals. One is to show how women have been a focus of much policy-making to date and the reasons for this. The second large task in the course is to consider how, given this background, women can intervene in the policy-making process to produce different outcomes. Feminist approaches to policy formulation also form a part of the course. The kinds of problems which will be discussed include: the difficulty of reconciling short-term proposals with longterm objectives; the need to devise policies sensitive to the 'differences' among women; the limitations of legal and legislative reform.

Dr Christine Beasley

Dr Chris Beasley is teaching three undergraduate courses for second and third year students while Dr Carol Bacchi is on leave at the ANU Women. Power and Politics is designed as an introductory overview of some contemporary debates in feminist thought and practice. A Survey of Feminist Thinkers attempts to explore in more detail several of the theoretical approaches that are raised in the first subject as well as other approaches, by concentrating on a number of contemporary feminist theoreticians. For instance, the work of writers like Carol Pateman, Luce Irigaray and Bell Hooks are examined. Women and Policy asks students to consider a wide range of contemporary policy areas such as economic policy, housing and the law. Analysis of policy is informed by discussion of theoretical questions concerned with the state and feminist strategies, in 1993 Chris will offer an honours level course entitled Sexual/Body Politics.

Dr Lenore Coltheart

Women in Australian Political **Development** is a first-year course for students of Politics which offers an opportunity to explore the nature of the political and the relationship of public and private spheres, with a focus on women and the state in Australia. The broad purpose is to increase our understanding of Australian political development, and to contribute to the analysis of reciprocal relationships between self and state. Lenore's 1992 Honours Seminar is intended to develop awareness of 17th century political ideas by discussing the work of prominent women intellectuals such as Aphra Behn, Anne Conway, Damaris Masham, and Mary Astell. One of the questions posed is whether their work is a minor contribution to 'western' political thought, or a major part of an alternative legacy.

Dr Carol Johnson

Dr Carol Johnson complements the work of the above Adelaide staff by incorporating substantial feminist segments into her undergraduate courses Australian Politics and Politics and Ideology, and into her honours course, Ideology and Meaning in Australian Political Discourse.

The Politics Department at Adelaide offers M.A.'s and Ph.D.'s by research. The department is committed to encouraging good female honours students to go on to postgraduate research and provides feminist supervisory expertise in a broad range of areas.

Gender and International

Politics: ANU, Canberra

Jan Pettman

Political Science AUSTRALIAN NATIONAL UNIVERSITY Canberra Australia :

Gender and International Politics is a Political Science year 2/3 elective which is cross-listed as a Women's Studies unit. It seeks both to 'gender' international politics and to interrogate the international aspects of gender relations. It does so around three broad questions: Where are women in international political relations and processes? Where is gender in international relations? What might feminist analyses contribute to our understandings of international politics?

The unit begins with a gendered analysis of the state and citizenship; and of women's roles in and relations with nationalism, ethnicity, migration and colonisation, and problematises the category 'women', attending to differences between different women. It then pursues issues to do with women and war and the gender of violence, utilising women's experiences and feminist analyses of militarisation and war. It also looks at women warriors, including women in stage militaries and in nationalist and liberation struggles.

From there the course examines the new international sexual division of labour, and women's roles in development processes and as labour migrants. It analyses women's rights cross-culturally, and the international politics of racialised domestic service, sex tourism and mail order marriages. It concludes with feminism and the politics of difference, asking

how an internationalised account of women's lives and struggles affects feminist analyses and alliances.

I gave an overview of the unit in a paper given at the recent Australian Political Science Association conference, entitled Gendering International relations, which is available on request from Jan Pettman Political Science, Faculties, ANU GPO Box 4 Canberra ACT Australia 2601.

GRADUATE PROGRAMME IN WOMEN'S STUDIES at ANU

ANU offers a Graduate Programme in Women's Studies which comprises PhD and MA-by-thesis programmes as well as coursework programmes leading to the Graduate Diploma and Master of Letters in Women's Studies. The Graduate Programme, while focused in the Women's Studies Unit in the Faculty of Arts, brings together staff and postgraduate students from a wide variety of disciplines across the University.

Students and researchers in politics will be interested to note that the Graduate Programme in Women's Studies may be based within the Women's Studies Unit or an appropriate cognate department, although thesis supervision can be drawn from across the University.

Location in the national Capital ensures that the Programme is particularly well placed for research into public policy issues affecting women.

Seminars organised by the Women's Studies Programme and occasional projects at the ANU provide useful resources for scholars in Women's Studies; from 1991-93 the Humanities Research Centre will focus on "Sexualities and Culture", and the Research Project on Changing Gender Relations in the Pacific and Asia, based in the Research School of Pacific Studies.
